## **Re: Bill 64, Cosmetic Pesticides Ban Act.**

On June 18, 2008 the Government of Ontario passed Bill 64 which will prohibit the use and sale of various pest control products for cosmetic (non-essential) purposes.

The Government of Ontario is currently developing draft regulations that will prevent many domestic pest control products from being purchased or used by Ontario residents.

The Government of Ontario is proposing to ban nearly 80 active ingredients and over 300 products that are used to control numerous pest problems even products to be used to control noxious weeds.

All Lawn Bowling Clubs in Ontario are asked to petition the Government of Ontario to ensure that, in the regulations being drafted, pesticides used in the maintenance of the lawn bowling greens/surfaces of the 140 lawn bowling clubs (and their 7700 members) be permitted to be used. Golf greens and lawn bowling greens require the same pesticides. If golf clubs receive special dispensation from Bill 64, then it would follow that lawn bowling greens would receive the same. To disallow the use of the current pesticides for the care and maintenance of lawn bowling greens would be the "beginning of the end" of a sport in Ontario that has been part of the sports scene for over 100 years.

Bowling clubs should petition both the Minister of the Environment and the Premier of Ontario before AUGUST 15, 2008
